## What is it

ISOPTT is a project that enables and facilitates small and micro enterprises to perform effective technology transfer and establish national and international partnerships.

#### General Information...

- Project partly funded by the European Commission
- Title: Increasing the Small and micro enterprises' Own Potential for TTT
- Duration: 2 years (June 1, 2006 May 31, 2008)
- Countries of pilot implementation: Germany, United Kingdom, Italy, Sweden, Greece, Bulgaria



# **Objectives**

ISOPTT aims at improving the capacity of small and micro enterprises to engage in efficient Transnational Technology Transfer (TTT) activities.

### **HOW**

...by transferring directly to the small and micro enterprises the specific **knowledge** required for effective transnational technology transfer (TTT).



# Knowledge required

ISOPTT seminars will focus on the following thematic areas as these are considered to provide a holistic approach to effective TTT...

- 1. Clustering
- 2. Globalisation Internationalisation
- 3. Intellectual Property
- 4. Financing
- 5. Competitive Intelligence Information retrieval



# **Activities - Services**

- 1. A series of 5 seminars for small and micro enterprises will be organised between December 2006 and May 2007, each dedicated to a fundamental topic of technological collaboration.
- 2. Identification of a group of interested, as well as committed companies
- 3. Close cooperation with those companies, and effort for the identification of their needs and priorities
- 4. One member of the staff will be assigned for the whole duration as responsible for supporting the company, handling and monitoring all interaction and collaboration



# **Activities - Services**

- 4. One member of the staff will be assigned for the whole duration as responsible for supporting the company, handling and monitoring all interaction and collaboration
- 5. Produce together with the company's staff an "action plan" with advice and guidelines on the topics of interest
- Provide services and continuous mentoring on the topic of their interest
  - Information
  - Advice
  - Signposting
  - Mediation
  - Search for partners
- 7. Monitor and evaluate the results

#### Small and micro sized enterprises that seek to:

- expand their business
- enter new markets
- establish new partnerships
- promote their products
- commercialise technological innovation
- assimilate new technologies
- enhance their position against competition, or
- simply identify their competences and needs

No restriction in the <u>field</u> of operation, <u>size</u>, <u>turnover</u>, <u>resources</u>, or the <u>technological level</u> of the company.



# **Expected outcome**

The participating enterprises will be able to handle effectively various aspects of the technology transfer process:

- access financial resources
- manage and promote the intellectual property of their company
- negotiate technology transfer deals
- identify opportunities and threats from internationalisation
- form strategic partnerships and benefit from networking
- retrieve and evaluate information on technologies, markets and competition



# The Open TTT project


- Experimental project supported by the European Commission.
