#### **Objective**

 To meet the arising need for a comprehensive monitoring tool, which combines the human rights approach of visitation mechanisms and other known tools at national, regional or local level with a more managerial perspective



#### Methodology

- Based exclusively on statistical data
- Universally applicable: not dependent on the specificities of countries and prisons
- Linked to international standards
- Reflecting comparable situations outside prison
- Focused on (material) conditions only
- Designed to assess entire prisons
- Best applied on annual basis
- Producing comparable results



#### **Indicators**

- Main indicators
  - Living conditions (21 sub-indicators)
  - Social work, free time and contacts with the outside world (20 sub-indicators)
  - Security and safety (16 sub-indicators)
  - Employment (12 sub-indicators)
  - Healthcare (23 sub-indicators)

#### Living conditions: sub-indicators


- Living area
- Occupancy
- Inmates in one cell
- Heating & ventilation
- Toilets
- Running water
- Alarm system
- Bath/shower
- Toiletries and cleaning materials

- Facility to obtain goods
- Windows (light, air, seethrough)
- Clothes and shoes
- Bedding
- Complaints
- Access to the prison management


### Social work, free time and contacts with the outside world: sub-indicators

- Social workers
- Education capacity
- Time locked in the cell
- Prison leave
- Correspondence & phone calls
- Visits: regular & intimate
- Adaptation programme: upon entry & before release

- Time in the open
- Sport facilities
- Library
- Legislation and legal literature
- Newspapers
- Computers
- Internet
- Television



## Social work, free time and contacts with the outside world: pilot results






#### Security and safety: sub-indicators

- Guards
- Violations: theft, damage, forbidden items
  & gambling
- Suicides
- Injuries: inmate-toinmate, inmate-to-staff, staff-to-inmate & selfinjuries
- Escapes

- Video control: perimeter fence, gates, common areas indoors, corridors, staircases & common areas outdoors
- Fire protection system: cells & common areas



#### Security and safety: pilot results






#### **Employment: sub-indicators**

- Employment capacity
- Choice of job
- Jobs for inmates with disabilities: vision, hearing & mobility impairment
- Salary
- Social security: working & nonworking inmates

- Professional qualification/vocational training capacity
- Allowances for unemployed inmates
- Working time and days off
- Occupational safety and health



#### **Employment:** pilot results






#### Healthcare: sub-indicators

- Health insurance
- General medical practitioners
- Nurses
- Dentists
- Psychologists
- Choice of doctor
- Inpatient treatment
- Medical examination: regular, upon entry & before release

- Transmittable diseases: tuberculosis, hepatitis B, hepatitis & HIV/AIDS
- Voluntary HIV testing
- Quarantine
- Medical visits to solitary confinement
- Sanitary inspections
- Prevention: syringes, substitute programmes & condoms




#### Healthcare: pilot results




