## Civil Society Facility and Media

*To strengthen participatory democracies and the EU integration process in the Western Balkans and Turkey by empowering civil society to actively take part in decision making and by stimulating an enabling legal and financial environment for civil society and pluralistic media.*

EU Guidelines for civil society and EU Guidelines for media as main driving mechanism for results-oriented assistance and policy dialogue

Strong HQs – EUD coordination mechanism (CS task force, CS working group)

Long-term grants, operating grants, sub-grants through CfPs, Grants to IOs, Technical assistance

Financial allocation for 2016-2017: 87.32 mln €, 2014-2015: 68.7 mln €, 2014-2020: more than 300 mln €, 2007-2013: 150 mln €

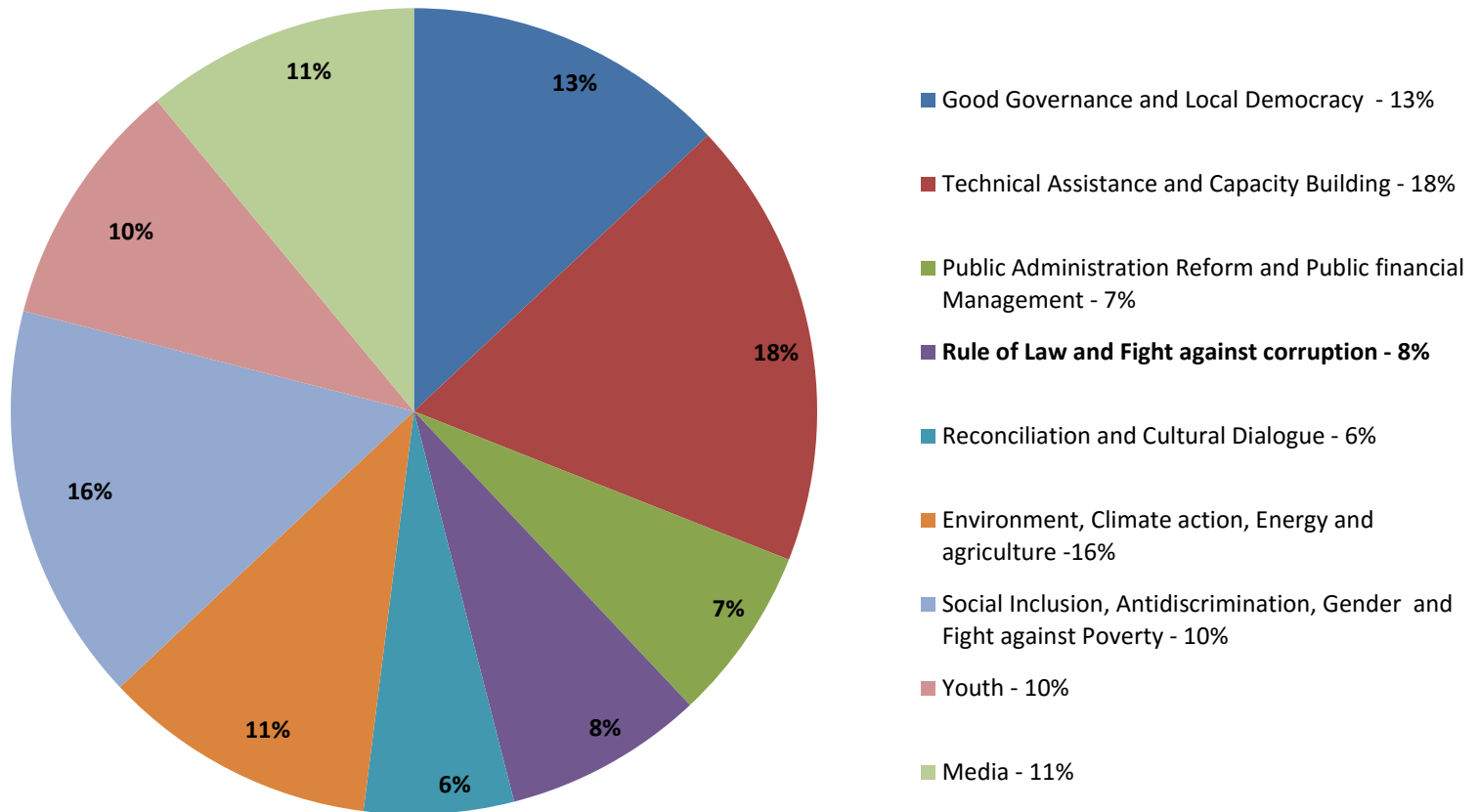

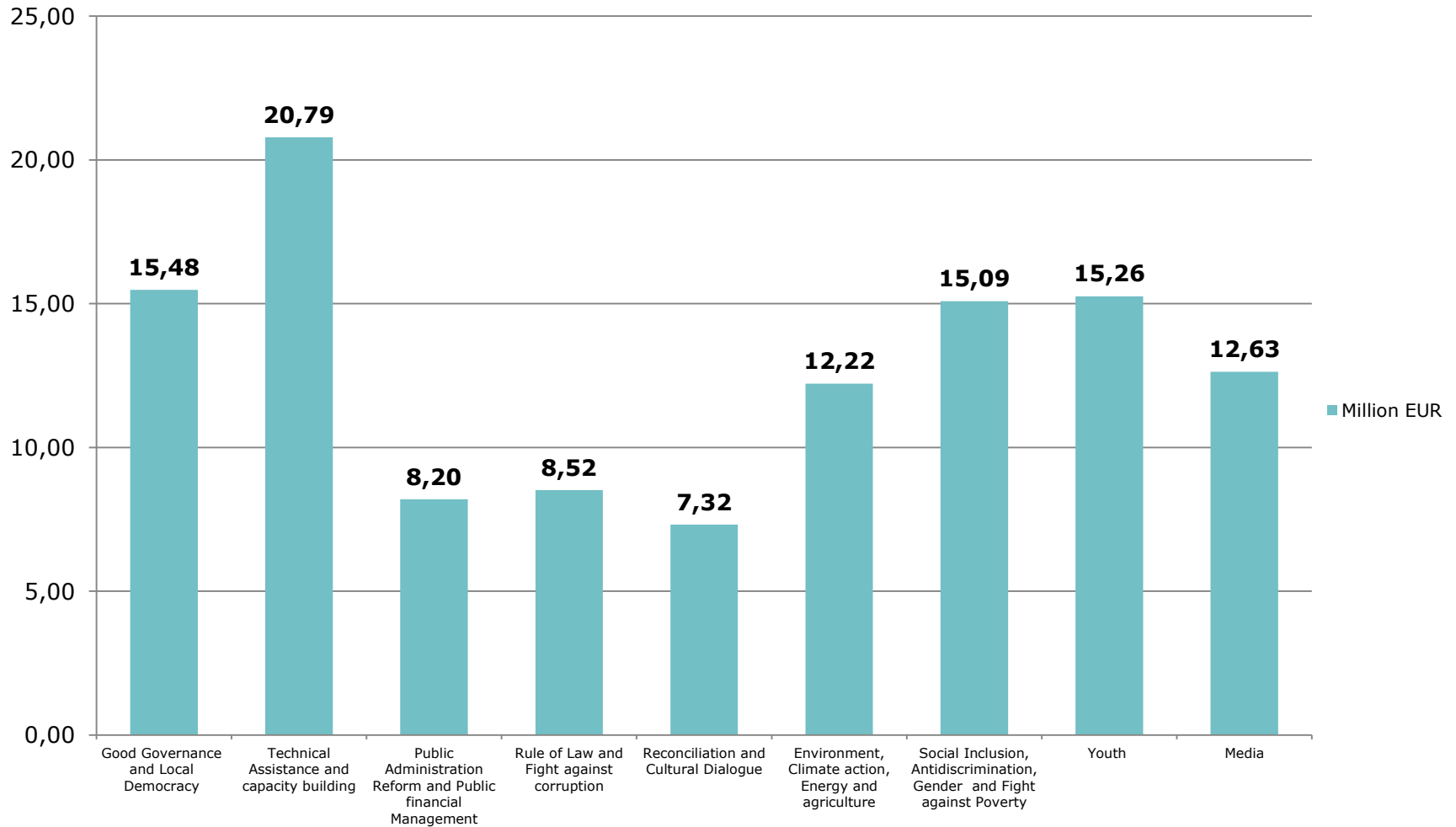

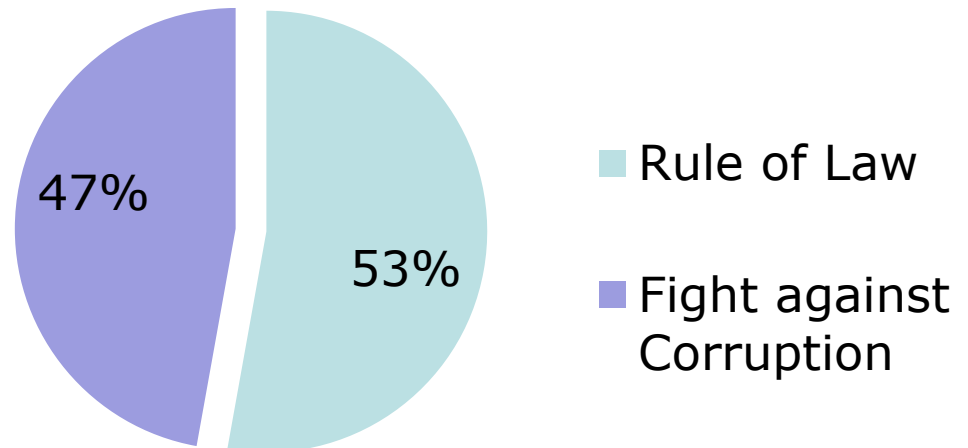

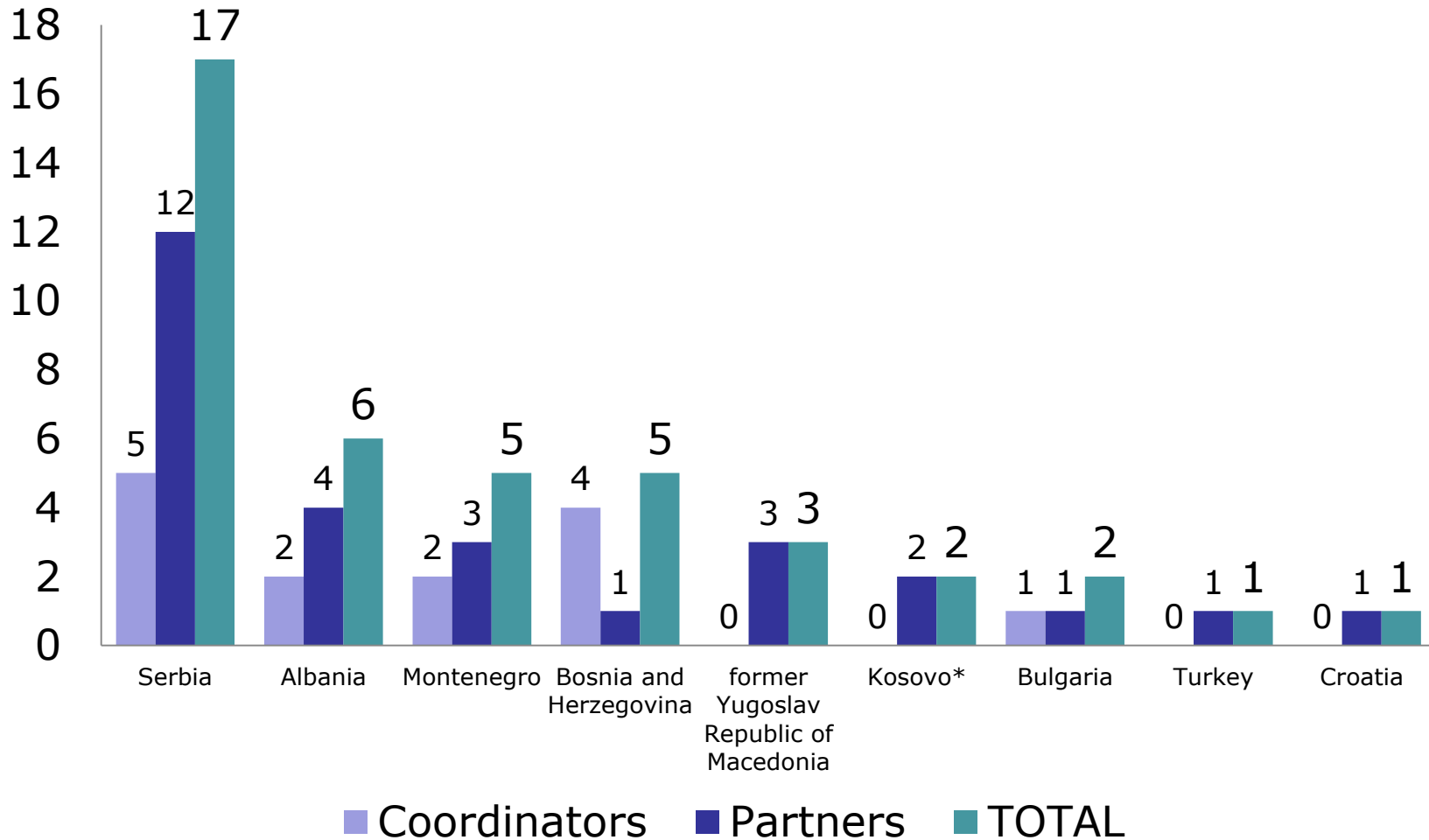
