





#### Case 3: Pharmaceutical Industry



General Insurance Company (VZP) and other insurance companies – hospital directors as board members

Draft ministerial decrees for maximum prices of products entering the market

Prices set the maximum refund by insurance companies to health practitioners

Practitioners (hospitals) close a contract with maximum prices and "return bonuses"

Insurance companies refund the maximum, but hospitals get kick-backs from the producer that they can spend on anything they wish to

2013 Babiš becomes the Minister of Finance


2017 Babiš puts his companies in trust




